NOTICE OF APPEAL

Pursuant to O.C.G.A. § 5-6-34, Petitioners hereby appeal to the Georgia Court of Appeals from all judgments, rulings, orders, and decisions in these consolidated cases that are adverse to Petitioners including, but not limited to, the Court's December 21, 2018 Final Order Granting Intervenor Georgia Power Company's Motions to Dismiss.

Jurisdiction. The Court of Appeals will have appellate jurisdiction to hear this appeal pursuant to Code Sections 5-6-34 and 50-13-20. The Court of Appeals will also have subject matter jurisdiction to hear this appeal because this case is not within the categories of cases reserved to the Supreme Court under Article VI, Section VI of the Georgia Constitution.

Record Designation. Petitioners designate the entire record for transmission by the Clerk to the Court of Appeals for the record on appeal. The Clerk should not omit any part of the record.

Transcript Designation. Petitioners designate all transcripts of evidence and proceedings for transmission by the Clerk to the Court of Appeals for the record on appeal. The Clerk should not omit any transcript. Petitioners' counsel have been informed by the Court reporter that all transcripts are being prepared and will shortly be filed with the Court. If it is later determined that any transcript has not been filed with the Court, Petitioners will cause such transcripts to be filed within the time periods, subject to extensions, required by the Appellate Practice Act.
